

## PRIZE DRAW RULES

These Rules govern the free entry route Prize Draw to receive *Samsung Galaxy Tab A 10.1-Inch 32 GB* opened by GT MOTIVE Ltd., a British company incorporated and registered in England, with tax number 843508133, whose registered office is at 1st Floor, Lynton House, 7-12 Tavistock Square, London WC1H 9LT (“GTM” or “We”).

Entrants into the Prize Draw shall be deemed to have accepted these Rules and any breach thereof would determine the exclusion of the participation in the Prize Draw.

The Prize Draw will be governed by English law and entrants to the Prize Draw submit to the exclusive jurisdiction of the English courts.

### 1. ELEGIBILITY AND ENTRY

Only one entry per business is permitted. Entries on behalf of another business will not be accepted and joint submissions are not allowed.

To enter the Prize Draw, entrants must complete an online review. No purchase is necessary. Entrants must provide the following contact details: Business Name, VAT number, Personal ID, Name and Surname, Residence, Phone number and Email. Entrants shall provide true data on the Prize Draw entry; winner’s identification will be evidenced with official documentation.

We accept no responsibility for entries that are lost, delayed, misdirected or incomplete or cannot be delivered or entered for any technical or other reason. Proof of delivery of the entry is not proof of receipt by GTM.

The opening date for entries is 00:00h on 06-23-2020. The closing date of the prize draw is 23:59h on 07-03-2020. Entries received after this time will not be considered.

## 2. DRAW

One winner will be chosen from a random draw of entries received in accordance with these Rules. The draw will be performed electronically at random. The draw will take place on a date between 07-06-2020 and 07-10-2020.

The winner will be notified by email within 48h after the draw. The winner must claim the prize within 24h by providing an UK postal address for delivery and by sharing with GTM and its Group companies a picture of itself with the prize visible (GTM and its Group companies may use winner's name and such picture for marketing purposes).

If the prize remains unclaimed, is claimed by a non-eligible entrant or is returned as undeliverable, We reserve the right to declare the Prize Draw null and void.

## 3. PRIZE

We disclaim all warranties, express or implied regarding the prize, including any implied warranties of merchantability, fitness for a particular purpose or noninfringement.
